#### 4. First Aid

#### 5. Fire-fighting Measures

#### 6.2. Environmental precautions

### 7. Handling and Storage

7.1. Precautions for safe handling: Always wash hands after handling. Ensure that there is adequate ventilation, especially in confined areas. Fire prevention : Handle in well-ventilated areas. Vapours are heavier than air. They can spread along the ground and form mixtures that are explosive with air. Prevent the formation of flammable or explosive concentrations in air and avoid vapor concentrations higher than the occupational exposure limits. Prevent the accumulation of electrostatic charges with connections to earth. The mixture can become electrostatically charged : always earth during decanting operations. Wear antistatic shoes and clothing and floors should be electrically conductive. Use the mixture in premises free of naked flames or other sources of ignition and ensure that electrical equipment is suitably protected. Keep packages tightly closed and away from sources of heat, sparks and naked flames. Do not use tools which may produce sparks. Do not smoke. Prevent access by unauthorised personnel.
